

WHISTLER SUMMER GETAWAY CONTEST

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Whistler Summer Getaway Contest (the "Contest") is sponsored by Elevate Vacations, located in Whistler, BC; Picnic Whistler, The Adventure Group (the "Sponsors"). There is one Prize to be awarded. Chances of winning depend on the total number of eligible entries received.

Who Can Enter:

- The Contest is open to residents of Canada and the United States of America,
 who are over the age of 25 Years at the time of entry.
- The Contest is subject to all federal, provincial, and municipal laws, and is void where prohibited.
- Employees of the Sponsors or any of its respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Contest and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of each such employee are not eligible. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Contest. Timing:

The Contest is open from 8:00 AM Monday, June 06, 2022, to Sunday, June 26, 2022, at 11:59 PM PST (the "Contest Period").

How To Enter:

- Eligible entrants may visit www.instagram.com/elevatevacations competition post (the "post") and www.facebook.com/ElevateVacationsWhistler competition post (the "post") or one of "the sponsors" post during the Contest Period and enter for the Contest. Entries are FREE. To Enter eligible entrants must follow the following Instagram or Facebook accounts: @elevatevacations, @picnicwhistler, @tagwhistler, @Thismamaloveslife.
- Entrants can earn bonus entries by visiting partner Facebook and Instagram pages during the Contest Period and tagging their friends/family in the comments of the 'Competition post'. Maximum of 100 entries. And by sharing the 'Competition post' on their (the Entrants) Instagram or Facebook story.
- Any use of electronic device to enhance or alter entrants' odds of winning will count as a fraudulent entry. Entries that are fraudulent are not permitted and will be declared invalid.
- The Sponsor reserves the right to delete any entries or remove participants that are in violation of the Official Rules.
- By participating in the Contest, entrants agree to be bound by these Official Rules.

Prize Draw:

- The random Prize draw of all eligible entries received will be held on or about Wednesday, June 29, 2022, at the administration office of the Sponsor.
- Following the draw for the Prize, the selected entrant will be contacted by email address or telephone number.





- To be verified the Prize winner, the selected entrant must:
- Respond to the prize notification email or telephone call within two (2) days of transmission.
- Sign a declaration stating that he/she:
- has read, understands and complies with the Official Rules;
- releases and discharges the Sponsor; and
- Consent to the announcement of the winner's name and the use by or on behalf of the Sponsor of the winner's name and/or photograph and/or video for advertising and promotional purposes, without any further compensation to the winner.
- Should the selected entrant fail to comply with any of the requirements contained in these Official Rules, the Prize will be automatically forfeited, and another entrant will be selected, and the initially selected entrant will be disqualified and will have no recourse towards the Sponsor or anyone involved in the Contest.
- Return of any prize notification email as "undeliverable" may result in disqualification, and an alternate winner may be selected.

The Prize:

- o Two (2) tickets to Vallea Lumina at The Adventure Group.
- One (1) Picnic Box to the value of \$85 at Picnic Whistler.
- The winners must be able to redeem their respective Prize before July 1, 2023. If the winners are not able to redeem the Prize during this time the prize will be forfeited and no alternative prize will be awarded.





- Accommodation at Elevate Vacations is subject to availability and normal vacation rental and hotel terms and conditions, alternate room style may be provided based on unit availability.
- Booking dates are subject to availability at the time of reservation and are subject to specific dates, do not include peak rates and are not valid in conjunction with any other offer and do not apply to groups. It may be subject to blackout periods and restrictions.
- A standard security deposit will be required on booking your dates.
- Any expenses not specifically mentioned above as part of the Prize shall be the sole responsibility of the winner. The Prize does not include any expenses related to meals, pre- and post-travel arrangements, accommodation incidentals (parking, phone, laundry, spa treatments, etc.), gratuities.

- The Sponsors will not, under any circumstances, be responsible for, or liable to any entrant or any other person for:
- any erroneous lost, damaged, late, incomplete, misdirected, deleted, defective, or altered Contest registrations, regardless of the cause, including, but not limited to, failure of the Site;
- any failure of any reason whatsoever of the selected entrant to receive a prize notification;
- o any changes in email addresses; and
- any computer, online, telephone, or technical malfunctions or errors that may occur, regardless of the cause.
- o If for any reason the Contest is not capable of being conducted as intended by the Sponsors, including due to computer viruses, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other cause that corrupts or interferes with administration, security, fairness, integrity or proper conduct of the Contest, the
